### **Introduction to Health Assessment**

#### **Course Outline**

#### **CALENDAR STATEMENT**

**NURSE 116: Introduction to Health Assessment\*4 (fi 8) (3-0s-3) over 15 weeks.**

The focus of this course is on the health assessment of the well adult with expected aging modifications. The course provides a beginning foundation of assessment skills and technologies necessary for determining client health status within the context of a nursing framework. Factors influencing lifestyles and personal health practices are included. Co-requisites are Nurse 113 and 114.

#### **COURSE DESCRIPTION**

This course provides an introduction to health assessment within nursing practice. Opportunity will be made available for practicing health assessment, communication skills, and applying health promotion as it relates to health assessment. In this course students will learn through several teaching/learning methodologies including lecture/discussion, demonstration, simulation and laboratory practice.

## LEARNING OUTCOMES

At the completion of this course, the student will be able to:

1. describe, understand and articulate an understanding of theory related to key patient safety concepts including communication, teamwork, environmental and human factors, safety risks and adverse events disclosure;
2. demonstrate, understand and articulate an understanding of theory related to patient centered care and interdisciplinary practice;
3. apply knowledge of anatomy, physiology, and pathophysiology during the physical examination of the well adult considering modifications for age;
4. demonstrate preparedness, professionalism, and appropriate communication skills, within the course;
5. describe the basic examination techniques and specific characteristics to be assessed during the physical examination;
6. provide rationale underlying the techniques used during the physical examination;
7. conduct a health history interview that reflects a comprehensive account of the adult client's physical, social, and mental health status with modifications for the client's age;
8. demonstrate a health promotion focus throughout the health history interview and physical examination;
9. perform a physical examination of a well adult client within the laboratory setting, using appropriate equipment and assessment procedures and techniques;
10. interpret subjective and objective data to validate findings and draw inferences on the client's health status;
11. differentiate between findings which are within expected limits, including age specific differences, and findings which would denote deviation;
12. document a comprehensive health history and physical exam using principles of recording.

## REQUIRED LEARNING EXPERIENCES

**Lectures:** This course will be facilitated using a variety of teaching/learning methodologies including lectures, demonstrations, simulation and laboratory practice. Students are expected to complete required readings prior to lectures and laboratory practice sessions.

**Laboratory Experiences:** Laboratory experiences occur within a supportive and safe learning environment. The intent of the laboratory learning experience is to facilitate students' psychomotor skills development; encourage critical thinking; and enable the application of theoretical concepts to clinical practice skills.

**Attendance in assigned lab section is required.** Students are responsible for making up a missed lab and can arrange this in consultation with the instructor. Preparation prior to each lab session is expected by completing assigned readings, assignments, and viewing relevant audiovisual resources. Students are expected to practice the skills taught in the labs outside of scheduled lab time at home or by arranging additional time in the lab when it is available. The grading method for lab evaluations will be pass/fail.

**Laboratory Evaluation:** Evaluation of psychomotor lab learning experiences will be completed by the instructor at the completion of all lab learning experiences using the system-specific Lab Evaluation Tool posted in Moodle. ## **THEORY COMPONENT**

N116 theory is divided into four units. The focus of the theory component is on helping students acquire and understand the knowledge necessary to be able to perform both focused and comprehensive health histories and physical examinations of clients across the lifespan. The theory component of the course will be facilitated using a variety of teaching methodologies including lectures, group work and videos. Students are expected to actively participate in the learning process and to come to all learning experiences having completed all required readings.

### 2. Midterm Examination (35%)

The mid-term examination will be computer-based. It contains 50 multiple choice questions and is weighted at 35%. Please see the course Timetable for date and time.

### 3. Final Written Examination (45%)

The final examination will be computer-based. It contains 100 multiple choice questions and is weighted at 45%. Please see the course Timetable for date and time.

### 4. Laboratory Evaluation (Pass/Fail):

Lab evaluation will be completed by the lab instructor at the completion of all lab experiences. Performance in lab will be evaluated using the system-specific Lab Evaluation Tools posted in Moodle.

A minimum grade of 80% is required in Lab Evaluation in order to pass the lab component of N116. To successfully PASS Nursing 116, students **MUST** pass the Lab Evaluation component. Students who do not pass the Lab Evaluation component on the first attempt will be required to complete remedial preparation prior to the second attempt. **Students will be allowed a maximum of two attempts to receive a passing grade in the Lab Evaluation.** Students who do not achieve a passing grade on the Lab Evaluation after 2 attempts will be awarded a failing grade of D in Nurse 116.

## EXAMINATIONS

All exams will be completed electronically through Moodle, Keyano College's Learning Management System. Examinations begin and end at the scheduled time. Students who arrive late will not be allowed to write the examination if any student has already completed the exam and left the room.
